**Background:**

The participating colleges in MoU wish to initiate collaboration of different departments of English in these colleges to support language and literary activities. Being located in rural and drought-prone area of Madha Taluka of Solapur District, the students of these colleges need proper guidance to enrich their knowledge and competency to be successful in their professional as well as social and personal life. Therefore, we agree to establish Language and Literary Association for academic cooperation in the area of mutual interest, and in accordance with terms and conditions set forth in this memorandum of understanding (MoU).

Objectives:

1. Exchange of information, notes and study material on subject teaching - learning materials for the educational development of the students
2. Joint organization of intercollegiate seminars in the subject of English at undergraduate level.
3. Exchange on a reciprocal basis, of students at graduate level for limited periods of time for the purpose of literary activities
4. To promote research activities in English language and literature.
5. Joint proposal and engagement in teaching learning processes or programmes by invitations to each other's faculty to participate therein.
6. To arrange exchange programs for students, teachers and alumnus.

Durations and Termination:

This MoU is valid for an initial period of five (05) years, commencing on the date of signing this MoU by the signatories of the representative depts. and institutions. The signing of the MoU will be followed by a review and assessment and may be extended on mutual agreement in writing. This MoU may not be amended or modified except with the written consent of both parties.

This MoU shall continue for the period of five academic years, June 2022-June 2027. The planning and activities of the MoU shall begin at the beginning of each academic year as per university announcements.

Either college can terminate this MoU for any reason, without liability, giving the one month's notice to the lead college in writing.

Meetings and Reporting

An MoU describes the interaction between the departments of English of the respective colleges. It provides a structure, such as a specific meeting time, or the "as needed" informal expectations of either college. It is also a way for parties to specify their reporting needs and timeframes.

To accomplish the purpose and objective set forth in the MoU, partners will meet at least twice a year. The lead college may arrange meeting at the beginning of the each academic year for annual planning and its execution of responsibility. The second meeting will be called at the end of the academic year for the review of the activities undertaken during the academic year. One more meeting may be arranged in the middle of the year as per the need and consensus of the participating colleges.


FUNDING

The departments under this MoU shall avail funding to implement the activities of the collaboration by the support of its' own college. Potential donors and funding agencies shall be sought by the department / college to achieve the goals and objectives of this MOU. The college agree that the financial arrangement for any event / activity undertaken under this MoU will be the sole responsibility of the organizing department / college. The other colleges will participate and shall not interfere with financial matters. There is no any kind of financial liability on either college or department.


